  - Email vote Motion: Due to the inherent difficulty of handicapping high-performance boats based on observed performance and comparable boats and in order to provide accurate PHRF ratings for boats with negative, or potentially negative PHRF ratings, we would like to strongly encourage our members to obtain and provide a rating certificate from a VPP-based rating system (ORC or ORR), before a PHRF SD certificate can be issued for 2022 and into the future. All boats with negative PHRF ratings will be reviewed before a 2022 certificate is issued and the submitted VPP certificate will be considered in addition to all other information used by PHRF SD in determining the revised rating. All affected boats are strongly encouraged to provide a VPP certificate, as soon as possible, so that a rating can be assigned before racing begins in January 2022. Please send that VPP Certificate to <chief.handicapper@phrfsandiego.org> This will apply to any boat that has all three ratings – Buoy, RLC, and OW - as negative but if your boat has one or more of these three ratings – Buoy, RLC, OW - as zero or positive you will not be required but only encouraged to submit a VPP certificate.

- TEMPORARY RATINGS ABOUT TO EXPIRE A Temporary Rating may be provided by Chief handicapper in the event a handicap is requested to race in an upcoming race which will take place before a meeting, and the board is unable to vote on the rating (Prior to race). The request should be email approved or voted on at next board meeting to make permanent. In the event at a board meeting where an owner has submitted an application, fees are paid, but the Board believes it does not have sufficient data or information to accurately rate a boat, a Temporary rating may be provided with the understanding the owner should submit race results during the three months to show data, to verify the Temporary Rating. Temporary rating may be adjusted after review of results. In the event the data is not provided the temporary rating will be considered expired at the end of 120 days. A new complete application (Minus Fees) will need to be presented to board to have the boat considered again for a PHRF certificate. The Chief Handicapper may, at his or her discretion, renew the Temporary Rating twice.
